Executive Summary

Providing safe and effective maternity and neonatal services remains a focus for the Integrated Care System. As highlighted within The Joint Forward Plan, supporting our children to have the best start in life is integral to the maternity and neonatal service delivery plans for the next five years. Ensuring our maternity and neonatal services prioritise and provide care which is safer, equitable, personalised, kinder and sustainable and ensuring positive work cultures and behaviours is a commitment of the ICB.

Nationally, there have too many examples of where care, outcomes and the experiences of women, birthing partners and neonates fall well below standards that we would hope for and expect. The ICB board and sub-committees continue to receive updates on the work underway across the system to respond to the lessons learnt from national and independent reviews into maternity and neonatal services. Ensuring the voice of our partners, women and those experiencing our services, is heard is one vital element in the ambition to continuously improve our services.

Recognising the location of the ICB Board today is in Buckinghamshire, hearing from a resident who has had experience of maternity and neonatal at Buckinghamshire Healthcare Trust is timely and appropriate.

Heidi Beddall (Director of Midwifery, Buckinghamshire Healthcare Trust) will present a video, which will detail the experience of a resident. **The video that will be shared at the meeting details pregnancy loss,** thus is sensitive and emotive in nature, yet also inspiring and hopeful.
